




The majority of the general fund expenditures are not included in the LCAP. These include predominantly salaries and benefits. Other expenditures include general operating expenses (utilities, etc.), instructional materials, special education costs, after school program costs, transportation and maintenance costs, and administrative costs.

Increased or Improved Services for High Needs Students in the LCAP for the 2022-23 School Year

In 2022-23, Douglas City Elementary School District is projecting it will receive \$153,552 based on the enrollment of foster youth, English learner, and low-income students. Douglas City Elementary School District must describe how it intends to increase or improve services for high needs students in the LCAP. Douglas City Elementary School District plans to spend \$282,301 towards meeting this requirement, as described in the LCAP.

This chart compares what Douglas City Elementary School District budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Douglas City Elementary School District estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2021-22, Douglas City Elementary School District's LCAP budgeted \$\$160,579.00 for planned actions to increase or improve services for high needs students. Douglas City Elementary School District actually spent \$\$143,310.00 for actions to increase or improve services for high needs students in 2021-22.

The difference between the budgeted and actual expenditures of \$-17,269 had the following impact on Douglas City Elementary School District's ability to increase or improve services for high needs students:

In 2021-22, Douglas City Elementary School's LCAP budgeted \$160,579 for planned actions to increase or improve services for high needs students. Douglas City Elementary School actually spent \$143,310 for actions to increase or improve services for high needs students in 2021-22. The difference had little or no impact on the students of Douglas City School. We were unable to fill all of our classroom aide position hours resulting in a difference between the expenditures budgeted and actually spent. Other staff was able to provide intervention to high needs students.

California's 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. The following is a one-time mid-year report to the local governing board or body and educational partners related to engagement on, and implementation of, these Acts.

The Budget Act of 2021 provided Douglas City Elementary School District with an allocation of Educator Effectiveness Block Grant (EEBG) funding in the amount of \$64,381, Expanded Learning Opportunity Program (ELOP) funds in the approximate amount of \$50,000, and Universal Pre-Kindergarten Grant funding in the amount of \$27,619 since the 2021-22 LCAP was approved.

Throughout the planning and decision-making process, we engage with our educational partners and will continue to as part of the on-going LCAP process.

We use the data gathered from parent and student surveys as input on how to allocate additional funding. Input on the use of state funds is also sought throughout the year from our Parent Advisory Committee, parent surveys, the district staff(classified and certificated), and the governing board at meetings and through conversations and interactions with all our educational partners.

The input was captured and represented in the Educator Effectiveness Block Grant (EEBG). Priorities were on providing for the coaching and mentoring of classroom teachers, content area professional development, strategies to support social-emotional learning, and strengthening the positive school climate. The district will continue to meaningfully engage with its educational partners as it does over the remainder of the year, and as described above, on the Expanded Learning Opportunity Program (ELOP), Universal Pre-Kindergarten (UPK), and any other federal funds through the LCAP process: community meetings, Parent Advisory Committee (PAC) and Parent Teacher Organization (PTO), and parent, student and staff surveys and discussions. The Expanded Learning Opportunities Program will be implemented in the 2022-23 school year.

The Unduplicated Pupil Percentage in 2021-22 is less than 55% and therefore Douglas City Elementary School is not eligible for concentration grant funds.

Douglas City Elementary School District regularly consults with our educational partners, which consists of families, students, teachers, administrators, school leaders, other educators, and school staff, for their input and feedback into the direction of the district and the use of federal funds. Throughout the planning and decision-making process, we have engaged with our educational partners and this continues to be an on-going process as a part of LCAP planning. We received Learning Loss Mitigation Funding (LLMFF), Governor's Emergency Education Relief Funding (GEER 1), and Elementary and Secondary School Emergency Relief Funding (ESSER II & III). The process for seeking input from our community and educational partners is the same for federal and state funds. We use all input when creating all plans. As we engaged our educational partners on the use of onetime federal funds received to support recovery from the COVID-19 pandemic and the impacts of distance learning on pupils we focused on the priority areas of the ESSER: strategies for continuous and safe in-person learning, addressing the impact of lost instructional time, and the use of any remaining funds. The District continues to gather input from our educational partners including the Parent Advisory Committee, Booster Club, all staff, the students, the parents and community and the governing board. We will conduct surveys in the spring to reassess and reevaluate our progress and goals.

The District's implementation of its effort to maintain the health and safety of students, educators, and other staff and ensure the continuity of services as required by the federal American Rescue Plan Act for 2021, and its implementation of the federal Elementary and Secondary School Emergency Relief (ESSER) expenditure plan to date is as follows:

To Safely Open and Operate Schools for In-Person Learning:

-install outdoor hydration stations, an outdoor shade structure for teaching/learning area, and additional outdoor seating which will allow more outside teaching and learning

-purchase personal protective equipment to replenish needed supplies throughout the course of the year

-purchase cleaning and sanitizing supplies for a clean and safe campus

Update as of 2/2022-we have finalized a contract and have on order hydration stations. Due to issues with the supply chain, we are hopeful that we will be able to have them installed this summer. A bid has been accepted for an outdoor shade structure. Due to weather and contractor availability, we plan to have the shade structure installed this summer if materials arrive in time.

Loss of Instructional Time

-hire additional staff to provide intervention and special supports to students during the school day and after school

-provide stipends to staff for increasing their day to provide additional academic supports

-provide professional development to staff to increase their capacity to offer high level instruction in all subject areas

-purchase supplemental academic materials for instruction and intervention

Update as of 2/2022-It has been increasingly difficult to find qualified staff to fill positions. We have also had the challenge of students having to miss school to quarantine due to a Covid exposure, leading to an increase in missed education. Due to a shortage of substitute teachers, staff have to search for virtual or out of working hours professional development opportunities they can attend on weekends or holidays so that

they don't need a substitute teacher.

The ESSER III Expenditure Plan was approved in October 2021, and therefore the District has had approximately three months (at the time of this writing) to implement the ESSER III expenditure plan. Some of the above expenditures will begin in late winter/spring of 2022. The District has through September 2024 to expend ESSER III funds, which it fully plans to do.

Plan Summary [2022-23]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Douglas City Elementary School is a one-school district in Trinity County, California encompassing an area of 125 square miles. The area served is composed of the residences in and around the small community of Douglas City. There are approximately 161 students in grades TK-8. The student population is limited in its racial diversity. Currently, 5% of our population are English Language Learner students. Approximately 13% of the student population participates in the resource Special Education Program. The Trinity County Office of Education's (TCOE) special education department provides quality, meaningful, and relevant educational support for students with disabilities. Special education programs meet the needs of students from various categories of disability through a collaborative model between our school and TCOE. This collaborative model includes support services, professional development, and communities of practice.

The school offers a well rounded education for all students. The school is staffed by a superintendent/principal, two administrative secretaries, business manager, nine regular classroom teachers, special education teacher, computer teacher, and P.E. teacher who are 100% appropriately assigned and fully credentialed. In addition, we staff a music/dance aide, art aide, Spanish aide, nine teacher aides, special education aide, two bus drivers, custodian, maintenance/transportation supervisor, cook, and cook assistant. After School staff includes site coordinator and five instructional assistants. The administrative team works cooperatively with each other, the school board, the staff, and parents to insure a positive environment.

All teachers in the LEA are appropriately assigned and fully credentialed with one teacher participating in induction activities to clear her credential. Every student has sufficient access to the necessary standards-aligned instructional materials.

The school facilities are in good condition as evidenced by our passing of the FIT report. Each year repairs and maintenance are performed as needed. We strive to provide a safe, clean environment for all our students.

The LCAP will serve in lieu of the Single Plan for Student Achievement (SPSA) and will include funds previously in the SPSA. Additionally, the LCAP stakeholder group will serve in lieu of the School Site Council.

The Trinity County Office of Education coordinates all county services for Foster Youth through the positions of Foster Youth Education Coordinator and Foster Youth Services Liaison. They provide support to our Foster Youth, placed both in and outside of our county, by helping with transfers, making sure records are moved quickly, and tracking attendance, suspension, expulsion rates and graduation rates to be sure that they are equal to those of their non-foster peers. They also intervene to refer or provide direct services, including transportation, as needed.

Because we are a TK-8 school the following state priorities and metrics do not apply to us: Priority 4B, 4C, 4D, 4G, 4H, 5C, 5D, and 5E. Because we do not have a significant population of EL students, the following state priorities and metrics do not apply: Priority 2B, 4E, and 4F.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Our school remained open for the 2021-2022 school year, offering full day in person instruction to all students. Our ASES program was run all year and was well attended. School sports and performances were able to be offered which encouraged students to engage more fully in school life and helped with attendance. We followed all county health COVID-19 regulations and instituted protocols to keep our students and staff safe. We continued to use our outdoor hand washing stations as well as using someone employed through the Smart Center to do extra sanitizing on campus.

We have a 20x60 shade structure project that will be installed on our playground. This will be used as an outdoor learning space during class time and PE and a covered area during recess and ASES.

There is no California School Dashboard data for our LEA. 2020-2021 CAASPP scores for ELA 71.30% and Math 71.56%.

We were able to hire a Spanish instructor partway through the school year for grades 5th-8th.

Reflections: Identified Need

Our chronic absenteeism rates increased due to to COVID-19 cases and exposures. We will focus on working with both parents and students to support higher attendance rates.

It has been a struggle to use district assessments are streamlined across the board for all grades. For the 2022-23 school year we have purchased IXL to benchmark all students three times a year as well as to offer some support with our students performing below grade level. This will provide valuable data for teachers and parents.

Staffing shortages and the lack of a qualified work force impacts our program. Professional development opportunities have been limited due to Covid concerns and our remoteness. We will continue to explore PD offerings and encourage our staff to participate.

We also need to work with our families to improve student attendance. We know that our students are more successful when they are able to be at school for instruction.

The annual and ongoing engagement of educational partners is a key part of DCESD's LCAP development process. It is important that the goals, actions, expenditures, metrics, and targets within the LCAP are informed by the voices of students, families, staff, and community members. The educational partners engagement process included school board meetings, Parent Advisory Committee, district surveys, public comment at the public LCAP meeting, parent and staff individual and group meetings. The engagement process was instrumental in the creation of the 2021-2024 LCAP. All meetings were offered in person. The Douglas City School staff is not represented by any employee unions or associations, therefore there are no bargaining units to involve in decision making. We do not have a significant English Learner student group, therefore we do not have an ELAC or DELAC.

Teacher collaboration is held weekly on Wednesdays. Collaboration includes regular reviews of our progress regarding school goals and what resources, training or collaborative efforts we need in order to increase our progress. Students were given opportunities to share feedback on curricular and extra-curricular offerings and options at the school. Student involvement included classroom meetings and discussions regarding programs, scheduling and future goals.

The LCAP was reviewed or opportunity was given for input during the following meetings:

LCAP Advisory/PAC Meetings (four times a year), Douglas City School Board Meetings (monthly), Staff Meetings (weekly) The Universal Pre-Kindergarten program and the Expanded Learning Opportunities program were both explained at the board, staff and parent meetings beginning in February 2022.

The superintendent met with the SELPA Administrator on May 24, 2022, and discussed the needs of students with disabilities in relation to the LCAP during the spring. Strategies included in the annual assurances support plan for the education of individuals with exceptional needs are in alignment with the LCAP.

Educational partners feedback influenced and drove LCAP development. We were able to incorporate all the previously stated feedback. There was overwhelming feedback stating that classroom aides were essential in helping to meet the needs of students not meeting benchmarks as well as in supporting classroom teachers in meeting the needs of students. Educational partners also shared their support in continuing programs such as Art, Music, PE, Spanish, ASES, Indian Education, and our sports programs. Academic interventions was also given full support by both parents and staff members in meeting the needs of students. Parents shared their appreciation for our PBIS program and highlighting a monthly character as well as a positive school climate on campus. Educational partners emphasized the need for continued reading support in the primary grades to address any gaps as soon as they are identified.

Paraprofessionals were hired to work in all grades, although we had a difficult time being fully staffed throughout the year.

Our SST Coordinator worked all year helping to facilitate behavioral and academic supports and interventions.

Students participated in Math Counts competition.

Music, PE, Art, Spanish, and Technology instruction continued throughout the entire school year.

Technology equipment was purchased and maintained to meet the needs of both students and staff.

CA State Standards curriculum was used in all classrooms.

Keyboarding was a part of students instruction throughout the school year.

Expenditures for PE/Health were higher due to an increase in benefits.

Expenditures for Spanish were lower due to not having an instructor the entire year.

Expenditures for Technology Instruction were lower due to time off without pay.

Expenditures for student chrome books were less because we purchased iPads that were less than the cost of chrome books.

Expenditures for CA State Standards Curriculum were less due to less need for curriculum than anticipated.

After assessing the needs, conditions, and circumstances of our low-income students, we learned that it is apparent that our current system is not adequately meeting the needs of our low-income students in the areas of attendance and academic progress. We found that the classroom environment, attendance rates and academic progress for low-income students are lower than the academic rate for all students based upon local data via our student information system and our localized benchmark assessment system in Math, Language, and Reading.

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate and less than proficient academic level will benefit. However, because of the significantly lower attendance rate and lower academic levels of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate and academic growth for our low-income students will increase significantly more than the average rate of all other students.

Using the calculation tool provided by the state, our LEA has calculated that it will receive \$153,552 in Supplemental and/or Concentration funding under the Local Control Funding Formula (LCFF).  - o This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)
